RESOLUTION NO. 17-XX

A RESOLUTION OF THE LAKEWOOD VILLAGE MUNICIPAL DEVELOPMENT DISTRICT ESTABLISHING A DEVELOPMENT PROJECT FUND AND DESIGNATING A COMMUNITY CELEBRATION OF THE 40TH ANNIVERSARY OF THE INCORPORATION OF THE TOWN OF LAKEWOOD VILLAGE AS A DISTRICT PROJECT.

WHEREAS, Local Government Code § 375.001 permits the creation of a Municipal Development District to serve a public use and benefit; and,

WHEREAS, the Lakewood Village Municipal Development District boundary includes all areas inside the Lakewood Village Extraterritorial Jurisdiction and inside the corporate limits of the Town of Lakewood Village; and

WHEREAS, the Town of Lakewood Village was incorporated in 1977 and this year will celebrate its 40th anniversary; and

WHEREAS, the Town of Lakewood Village is a municipality has a population of fewer than 20,000 citizens.

WHEREAS, Local Government Code §505.158 permits the board of directors to approve expenditures on any project it determines to be an expenditure which will promote new or expanded business development.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE LAKEWOOD VILLAGE MUNICIPAL DEVELOPMENT DISTRICT, THAT:

SECTION 1. The findings set forth above are incorporated into the body of this resolution as if fully set forth herein.

SECTION 2. The Municipal Development District Board of Directors hereby determines that hosting this community event is beneficial to aid in attracting new, ~~and maintaining~~ or expanding, ~~business~~ within the district by providing networking and advertising opportunities.

1. The Town of Lakewood Village will provide a listing of all existing businesses within the Town of Lakewood Village and its surrounding ETJ to the Municipal Development District Board of Directors.
2. The Town of Lakewood Village will provide a listing of active developers currently active within the Town of Lakewood Village and its surrounding ETJ to the Municipal Development District Board of Directors.
3. The Municipal Development District will contact each business owner / developer to participate in the anniversary celebration. Written commitment will be suggested.

4. The Municipal Development District will promote new business development within the Town of Lakewood Village and its surrounding ETJ. The Lakewood Village Town Counsel will support business development.
5. The Municipal Development District Board of Directors will support the Town of Lakewood Village anniversary celebration if businesses will actively engage in the event.
6. A maximum budget of \$xxx will be made available.

There was some discussion about the community event scheduled for October 14th celebrating the 40th anniversary of the incorporation of the Town of Lakewood Village.. Councilman Clint Bushong reported that he knows where the board could purchase cooked and sliced brisket for \$10.00 per pound, and pulled pork for \$5.00 per pound. Paul Bowers recommend that the board contact Sam Fleitman, who lives on Carrie Lane, to see if he would be willing to cook for no additional cost other than the price of the meat. Paul Bowers will get in touch with Sam Fleitman. Secretary Asbell. Confirmed that the band, No Wake Zone, would like to perform during the event and would not charge any fee.
